IN ADDITION TO BEING CERTIFIED AS A USPTA (ELITE PROFESSIONAL) PRO, STEVE IS ALSO CERTIFIED AS A HIGH PERFORMANCE COACH BY THE USTA AND USPTA. IN 2012 STEVE WAS CHOSEN BY THE USTA INTERMOUNTAIN TO COACH THE INTERSECTIONS BOYS AND GIRLS 16's TEAM IN SHREVEPORT, LA. FROM 2008-2009 STEVE COACHED THE MEN'S TEAM AT THE UNIVERSITY OF NORTHERN COLORADO, THE ONLY PUBLIC D1 MEN'S PROGRAM IN THE STATE. IN THE SUMMER OF 2012, STEVE STARTED AS THE DIRECTOR OF ADIDAS TENNIS CAMPS OUT OF COLORADO STATE UNIVERSITY. STEVE PLAYED #1 SINGLES FOR HIS H.S. AND ALSO PLAYED COLLEGE TENNIS ON A SCHOLARSHIP.
